Dear Parent/Guardian,

School Tuition Organization of Southeast Iowa (STO) and Holy Trinity Catholic Schools are pleased to announce a program that provides tuition grants to qualifying families. The School Tuition Organization (STO), combined with our local grant programs, offers expanded opportunities to help qualifying families afford Catholic education.

STO tuition grants are available to students entering K-12<sup>th</sup> grade, who live in an Iowa household, and whose total income does not exceed an amount equal to four times the federal poverty guideline.

Holy Trinity also has local funding to provide tuition awards over and above the STO program, thus providing more supplementary tuition grants. Our local grant program is open to all qualifying families, not just those who qualify for the STO grants. In order to be considered for additional grants the STO application must be filled out and returned by April 15, 2020.

Both STO and Holy Trinity will be utilizing the Southeast Iowa STO office to evaluate the applications. The STO office determines the amount each family is eligible for. The application form is a (two sided) document that all families need to complete to be considered for any award, including HTC Foundation and Vonderhaar tuition grants. You must include a copy of your 2019 federal income tax return (specifically the first two pages of your 1040 form). Your personal information will be used only by STO and will be held in the strictest confidence at all times. If you have a child at more than one Catholic school, you will only need to complete one application form. COMPLETED APPLICATIONS MUST BE RECEIVED OR POSTMARKED NO LATER THAN APRIL 15, 2020 to be considered for STO funding for the 2020-21 school year. Applications postmarked after April 15th will not be considered for STO funding.

An application form is enclosed with this letter, available at Holy Trinity school offices (including HTC ECC), and downloadable from the Holy Trinity School website at <a href="www.holytrinityschools.org">www.holytrinityschools.org</a>. If you have any questions you are welcome to call Nicole or Sasha (319-837-6131) at the school for assistance. Completed applications and copies of pages 1 and 2 of your 2019 federal tax return are to be submitted to the Holy Trinity Business Office in West Point.

Award notification letters will be mailed from the school by the first part of July.

We require every family who wishes to receive tuition assistance to complete an application. The School Tuition Organization of Southeast Iowa (STO), coupled with our local tuition grant program, will be able to help all families with demonstrated need.

#### **Program Information**

The School Tuition Organization of Southeast Iowa is funded by numerous generous donors from across Southeast Iowa. Donors receive an Iowa Income Tax Credit equal to 65% of their gift, and a federal tax deduction if they itemize. Donors interested in contributing to this program during 2020 can go to <a href="http://stoseiowa.org">http://stoseiowa.org</a> for more information.

Families residing in Iowa are eligible for STO grants if their total gross income for 2019 is at or below 4 times the poverty level. The poverty level is set by federal guidelines. The level of STO grant funds will be based upon family income, number of dependents, and the total K-12 tuition bill for the family.

All families who want to be considered for a tuition grant (STO grants as well as local scholarships and HTC Foundation grants) must fill out the STO application.

<sup>\*\*</sup>Family size includes parents/guardians plus total number of dependents claimed on 2019 tax return.

<sup>\*\*\*</sup> Families are eligible for STO grant if their total income is at or below the above listed income levels.

Local assistance is not based upon the above. Falling within these guidelines does not necessarily guarantee a tuition grant. \*\*\*\* For each additional dependent add \$17,920.

HTC is committed to making tuition affordable for students from all economic backgrounds through need-based tuition assistance grants.

Holy Trinity Catholic Schools offers financial assistance to students whose families demonstrate financial need. Based on available funds and the number of applicants each year, HTC makes every effort to provide assistance to those families who need help. Currently, 51% of students receive some type of financial assistance.

All HTC families in need of financial assistance are encouraged to complete the STO application. All families applying for financial assistance must submit their most recent Federal tax returns. All financial information is held in the strictest confidence by our Rusiness Office.

If you are applying for any grant or scholarship, you must complete the STO application to be considered. Grants, Scholarships and/or Financial Aid will not be provided for those who do not complete the STO application.

Families are required to reapply for financial assistance each year. Every attempt is made to provide ongoing assistance to those returning students that demonstrate continued need. Financial assistance decisions are made separately from the admissions process and have no impact on a student's eligibility for admission to Holy Trinity Catholic Schools.

#### HTC offers a number of ways to make Catholic education affordable to our students.

- ❖ STO~ DUE EACH YEAR BY APRIL 15, 2020. The application form can be found on the Holy Trinity school website (www.holytrinityschools.org) under the admissions tab. Or you may pick up a paper copy at HTC High School, Elementary or ECC buildings. Completed applications must include a copy of your 2019 Federal Income Tax Forms 1040, 1040A or 1040EZ. IF you were not required to file a tax return, submit W-2 and 1099 forms with your application. All information is then forwarded to the STO Administrator in the Quad Cities for evaluation and are not reviewed locally. We do not keep copies of your tax information.
- Holy Trinity Educational Foundation~ All families who apply for STO grants are eligible for an additional grant from the HTC Educational Foundation. Foundational grants are based on need not met through an STO Award.
- ❖ Scholarships & Grants~ These are created and funded by private donations and benefactor memorial gifts. The criteria used for each scholarship is specific to each fund. Scholarships vary from year to year. The deadline for grants and scholarships are April 15, 2020.
- ❖ Scrip~ All Holy Trinity families can lower their tuition costs by taking advantage of our Scrip program, regardless of their eligibility for financial assistance. Friends and relatives are welcome to name your child as the recipient of their earnings for additional savings for you. Scrip credits are applied to tuition statements in May.   received by that date will be considered for funding by the STO of Southeast Iowa. Late applications will be
  processed only for purposes of determining your qualification for other financial aid.
- Your financial need is determined by reference to your household's size and income. The term "household" refers to all individuals who live in the same dwelling place, regardless of age, legal relationship, or dependency status. Your household may include different people than those in your family.
